POSITION SUMMARY

Under the direct supervision of the **Lead Promotor**, the Promotor Comunitario will conduct outreach, educational and enrollment activities in ten **UCSD Mas Fresco** special community events scheduled at North Gate Markets in **San Diego County**. The Promotor Comunitario is responsible for completing the required programmatic reporting in a timely manner.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Maintain consistent and constant communication with the Lead Promotor regarding all pertinent Mas Fresco activities assigned.
- Participate in the three day five hour UCSD Mas Fresco training in February 25 to Feb 28. (~26 hrs. of training).
- Participate in the outreach, educational and enrollment events, scheduled from February to April 2019 by the UCSD Mas Fresco program at the North Gate stores # 21 and # 36 located in San Diego, California.
- Meet and greet the North Gate Market clients during the enrollment events in English and Spanish.
- Educate the North Gate clients about the UCSD Mas Fresco Program benefits and requirements.
- Follow the UCSD Mas Fresco guidelines to enroll clients into a formal study.
- Maintain accurate, up-to-date records and files on all outreach and education activities conducted, including any
 documentation applicable regarding the requirements for eligibility and compliance with the activities.
- Maintain consistent and constant communication with the Lead Promotor regarding all program components
- Attend all scheduled meetings with the project team, as needed.

Other duties may be assigned. The duties listed here are typical examples of the work performed; not all duties assigned are included, nor is it expected that all similar positions will be assigned every duty.
