POSITION SUMMARY

Under the direct supervision of the **Program Manager**, the Promotor Comunitario will conduct outreach, educational, and referral activities in Santa Barbara County. The Promotor Comunitario is responsible for completing the required programmatic reporting on time.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Provide time and support to the Pathways to Employment project: reach out to the community to inform and engage.
- Identify and secure potential sites and groups to provide information about Pathways to Employment Project.
- Conduct education activities to give information about Pathways to Employment Project.
- Refer participants to the Pathways to Employment Project.
- Participate in the outreach and educational process scheduled from July 2020 to September 2021.
- Plan and organize outreach and education activities.
- Maintain consistent and constant communication with the Program Manager regarding all program components.
- Follow up and help the participants to navigate the CalJobs system.
- Assist with the recruitment of promotores in the North and the South to participate in the Pathways cohorts
- Assist with the recruitment of promotores as expert mentors in the North and the South.
- Distribute publicity materials to engage promotores, CHWs, and interested residents in the job fairs, panel presentations, Workforce Readiness Training, and other events
- Follow up to the participants of the cohorts.
- Attend all scheduled meetings with the project team, as needed.

Other duties may be assigned. The duties listed here are typical examples of the work performed; not all duties assigned are included, nor is it expected that all similar positions will be assigned every duty.
