## SIX STEPS TO TAKE

- Memorize the phone number of a trusted loved one. Choose someone you trust and who will reliably pick up the phone when you call. If you already have one number memorized, you can challenge yourself to memorize two more!
- Complete an Emergency Contact Phone
  Tree. This phone tree is an easy and effective
  place to start with critical information, just key
  names and phone numbers. Simply follow the
  prompt! You can fill this out digitally or print
  and post at home. This mighty tree can also
  come in handy in case of a power outage or
  lost phone!
- Fill out and share a Safety Plan with trusted loved ones. Linked below are some of our favorite safety plan templates. These are trusted, vetted, and comprehensive! You can print these and take your time slowly filling in the information, or you could make a family night of it. Once you fill in this safety plan, save it in a secure location, along with your key documents.

Remember, every person in the U.S., regardless of their immigration status, has constitutional rights. Here are <u>eight actions</u> to exercise our rights.

Verify that you have valid and appropriate documents to travel!

AIRPORTS: Beginning May 2025, all U.S. travelers will need a REAL ID-compliant form of identification to board domestic flights or enter certain federal facilities. Each state has different REAL ID compliance requirements. Learn what is acceptable identification in airports and which documents you can use to travel in your state.

IMMIGRATION DOCUMENTS: Certain immigration statuses require you to carry additional proof of your status at all times. This could include documents like your Permanent Resident Card (Green Card), Employment Authorization Document (EAD), or other USCIS-issued paperwork.

Make sure your documents are valid, up to date, and safely stored while traveling. For specific guidance, consult an immigration attorney or trusted legal resource.

- Make copies of key documents and store them all in a secure location. Refer to your safety plan for a complete list!
